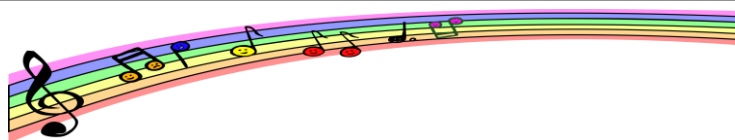

- Nominees must be members in good standing for 180 days prior to running for office, except the President who must have been a member in good standing for one (1) year

Pay by club check whenever possible; give a statement of finances at general membership meetings or as requested by the board. Turn over all applications for membership to the Secretary promptly.
