NOMINATIONS FOR OFFICERS FOR 2018

REMEMBER September 10, 2017 at 5:30 p.m. General Membership Meeting.

At this meeting, Vicki Cash, our Nominations Chairperson, will be accepting nominations of officers for 2018.

KEEP IN MIND that anyone running for President must be a member in good standing, without any lapse in membership, for a period of one year. According to the Bylaws, under Section III, Subsection b, any member who renewed after the cutoff date of January 31, 2017, is considered a new member.

Anyone running for 1st Vice President, 2nd Vice President, Secretary or Treasurer must be a member in good standing for 180 days (or 6 months) prior to running for office.

If you have any questions about the rules, please consult with Vicki Cash, who will also have the forms needed to file.

NOMINATION OF OFFICERS FOR 2018

The time is approaching for the nomination of officers for the calendar year 2018.

Attached is the form to submit for nominating either yourself or another member (with his or her approval) to run for office.

Nomination forms must be received on or before the General Membership Meeting on September 10, 2017.

Officers include: President, 1st Vice President, 2nd Vice President, Secretary and Treasurer.

The attached form explains the duties of each office. If you wish to be placed on the ballot, you have the option to indicate your first, second or third choice.

If the Nomination form is signed indicating the nominee agrees to be a candidate, the nominee need not be present to accept or decline. However, the nominee must be present to accept or decline if nominated from the floor.

The name of all candidates will be published in the October Newsletter, along with the election location, date and polling hours, along with instructions for absentee ballots. Each candidate will be allowed reasonable space in the newsletter for their resume.

- No candidate may be nominated for more than one (1) office.

- No relatives may hold an office at the same time.
- Nominees must be members in good standing for 180 days prior to running for office, except the President who must have been a member in good standing for one (1) year

() Second Vice President

Assist First Vice President and perform such duties as prescribed by the Board

() Secretary

Take minutes of meetings, read minutes of previous meeting and any important correspondence, and maintain an updated membership roster.

() Treasurer

Receive and bank all money due the club, keep bookkeeping records of such funds, pay bills for the club from officers and members only when clearly authorized by a member of the board and when receipts for expenditures are provided. Pay by club check whenever possible; give a statement of finances at general membership meetings or as requested by the board. Turn over all applications for membership to the Secretary promptly.
