# REMEMBER September 10, 2017 at 5:30 p.m. General Membership Meeting.

At this meeting, Vicki Cash, our Nominations Chairperson, will be accepting nominations of officers for 2018.

KEEP IN MIND that anyone running for President must be a member in good standing, <u>without any lapse in membership</u>, for a period of one year. According to the Bylaws, under Section III, Subsection b, any member who renewed after the cutoff date of January 31, 2017, is considered a new member.

Anyone running for 1<sup>st</sup> Vice President, 2<sup>nd</sup> Vice President, Secretary or Treasurer must be a member in good standing for 180 days (or 6 months) prior to running for office.
