THE PRESIDENT'S CORNER

Welcome to July!!

We are planning on having a great barbeque party. If you haven't registered yet, please do so. We wouldn't want you to miss out on 1 of 9 \$25 gift certificates we will be giving out. Great music, good food and friendly people.

Section II, Paragraph (b) will change from 45 days to 90 days for the membership to approve the proposed budget.

Section II, Paragraph (f) will change to indicate we will no longer need a quorum of 15% of the total membership. At all our meetings, it will be majority rules. In other words, members that attend our membership meetings will be making decisions of the direction of our club and any changes to our by-laws. This is a great reason for members to attend our meetings and get involved. The next General Membership Meeting is September 7, 2014 – nominations for officers. Mark your calendar, please!!!!

Orange Squeeze – Wednesday, October 29, 2014. Beach Boppers will be dancing outside from 6 p.m. to 10 p.m. – under the tent with the ocean breeze on the new floor!!! DOROTHY BERDELLANS

Dorothy was born in Brooklyn, New York. At age 7, her family moved to a little town in the foothills of the Catskill Mountains. She has one brother, who still lives there. She graduated from Fallsburg Central High School in 1955. Dorothy lived in Woodbourne until 1958 when she married her first husband and moved back to Brooklyn. After her separation from her husband in 1965, she moved back to Woodbourne with her two children, Steven and Liz.

In 1974, she moved to Margate, Florida, where she lived for 30 years. She went to work for a court reporting company and became a partner and remained so for 20 years until she sold her interest.

Dorothy married her late husband in 1983. They had a blended family, which now consists of her 2 children, his 2 children, 8 grandchildren and 3 great grandchildren, which made any time they get together hectic and a lot of fun!!! In 2004, after the death of her husband, Dorothy moved from Margate to Winter Springs. She went to work for Mortgagee Title Services as a closer and title agent in 2005. She is now retired.

One day in April 2006, her daughter Liz had to go to Ormond Beach to meet with a builder and asked her to go along for the ride. So, reluctantly, she went that evening. Gene Nash and Jerome Schiff were patient enough to teach her some of the dance steps, and her interest in dancing and the Beach Boppers grew. Dorothy and Toni definitely hit it off – they became best friends, more like sisters.

One day, she was asked to run for Treasurer of the club. That was in 2009 and she has been doing that ever since. When Diane Scott stepped down from doing the newsletter, Dorothy volunteered to help until someone else took it over. When you talk to Dorothy, she will tell you that one of the best things that happened to her was meeting Toni and joining Beach Boppers.
