David Beauchamp was born in Racine, Wisconsin. He attended St. Catherine's High, University of Wisconsin Park Side, Carthage College and Marquette University. Dave moved to Orlando in November, 1976.

Dave has four brothers and two sisters. He is married to Lany. He and Lany are the owners of the Cutting Edge Hair Salon. And, as he says, “otherwise retired after working 53 years in different fields.”

He loves to travel across the country to other dances and he has sponsored junior and masters division dancers.

He and Lany have competed in many different dance competitions. They won the 2012 National Smoothies Dance Championship in North Myrtle Beach, South Carolina. In 1997, Dave won the National Hall of Fame Dance Championship. He has also been a judge and has competed in the National Line Dance Championship in Greenville, South Carolina. In 2008, Dave was inducted into the Florida Shag Hall of Fame, and in 2010 he was inducted into the National Living Legends of Dance.

In 1985, Dave went to Myrtle Beach, South Carolina, and, at that time, met Lynn O'dell, Butch Berry and many more dancers from Florida. He was so impressed with the music and the different dances, especially Shag and Bop. When he returned to Orlando, he became a cofounder and charter member of Beach Boppers of Orlando. He has held many positions in the club since then. He was President of Beach Boppers when the club was awarded “The Shell Award” in 1997 for being the best dance party in the country! That was quite an honor for the club.

Although Dave and Lany do not live close now, they have remained faithful members and continue to support the club in every way that they can.
